#### **International Centre for Missing & Exploited** Children and Heal Trafficking- Documenting ICD Codes and Other Sensitive Information in **Electronic Health Records**

The following guidelines were developed by a subcommittee of stakeholders, including survivors of labor and sex trafficking, and were

written to reflect a trauma-informed, rights-based approach (please see Resources at the end of this document for information on trauma-informed care). The guidelines aim to educate HCPs about how to work with trafficked/exploited/abused patients when making decisions about use of ICD codes and documentation of sensitive information in the electronic health record (EHR).
